# New York State Concealed Carry Recertificatio 2025 Newsletter Urgent Message to Permit Holders

There is a BIG change in the "Concealed Carry Improvement Act of 2022".

I learned via the March 21st Issue of the New York Outdoor News, Page 2. Article by Ray Kosorek, Director of Gun Owners of America, New York. I confirmed the author's comments online with New York State.

People who possess a Concealed Carry Pistol Permit in New York subjected themselves to an investigation, provided personal references, and underwent a thorough background check by law enforcement. We were fingerprinted and had our photos taken. Applicants waited for months for the signature of a judge affirming that the authorities would allow us to carry a firearm. A New York concealed carry permit was then issued for the life of the recipient - unless revoked for cause. That was up until 2022.

In 2022, because of the numerous and heinous crimes committed by NY licensed permit holders, (sarcasm intended) our governor and the legislators in Albany enacted into law, the "Concealed Carry Improvement Act".

One key requirement of the CCIA was the compulsion of all permit holders to perform a five-year self-re-certification of their permits with the New York State Police. Those failing to perform this recertification are subject to having their permits revoked. Like most permit holders, I complied with CCIA and went online in August 2022 to recertify my permit, (held since 1979). I filed the confirmation and made myself a note to repeat the self-reporting, as required, in 2027.

**The BIG change:** The NY legislature quietly moved the recertification requirement period for permits to THREE Years. Authorities notified none of the registered permit holders. The State says that you are supposed to be aware of the change. Online, I found that my own recertification will expire this year, not in 2027 as documented at the time of my initial submission. I have a family member that shares registration on a firearm with me, who received their permit four years ago. That person had no way of knowing that they are NOT in compliance with the new CCIA 3-year mandate.
